## Rules

1. Open to all USBC sanctioned LOOM or WOTM in good standing. All bowlers will be required to show a USBC sanction card and a valid Moose card at check-in, which is 30 minutes prior to your scheduled squad. Bowlers with no USBC sanction may qualify by paying unattached USBC fees. Lodges and chapters must be in good standing.
2. No bowler may participate more than once in each event, except for members of the host lodge which will be allowed to bowl more than once in cases of emergency where a bowler is absent and other replacements cannot be found. The house chairman must approve any such substitutions. Only entries paid in full will be accepted. Bowlers entered in singles or doubles must be entered in both events. Line-ups will be as listed on tournament entry form.
3. Tournament Averages: All bowlers will use their highest USBC average for 2010-2011 season, 21 game minimum, Summer league averages will count. Bowlers with no average last season will use their highest average (21 game min.) as of Jan. 1, 2012. All others will bowl scratch. If a submitted average is different than the actual average, the handicap will be adjusted for the correct average. Bowlers using a Jan. 1, average must submit written verification at time of entry. Last minute substitutions using a Jan. 1 average will have 5 days to submit written verification of average.
4. Handicap: Will be 90% of 230 for all bowlers, using a single game chart and added to a bowler's actual score.
5. There is no 10-pin rule for this tournament. Report of previous prize winnings will not apply, USBC Rule #319-D and #319-E will not apply.
6. All prize money will be returned 100%. The tournament will pay at least one place for every 10 entries in each event, except All Events, which will pay 1 place for every 20 entries. If a bowler bowls more than once in an event, only the first time will count towards all events.
7. Breakdown of entry fee:

8. Bowlers will be notified of squad times only if these times are different from the times they requested.
9. The House Chairman is Jerry Mabry and the Tournament Director is Gerry Zirk. Any questions not covered by USBC tournament playing rules will be the decision of the Tournament Director and House Chairman. Their decision will be final, unless an appeal is made in accordance with USBC Rule #329.
10. Changes after entry has been mailed should be called in to Gerry Zirk at 540-381-3007.
11. If after an event has been started and it is necessary to move a pair of lanes due to mechanical breakdown the bowlers will receive no practice frames on the new pair.
